**BY-LAW NO. 2533**

**A By-law to amend Village of Port Stanley By-law 1507**

**THE COUNCIL OF THE CORPORATION OF THE MUNICIPALITY OF CENTRAL ELGIN  
ENACTS AS FOLLOWS:**

1. Map Part 2(bd) to By-law 1507 as amended is further amended by deleting the “h1” and “h2” from the Special Zone symbol “h1 h2 R1-72” in respect of the lands shown as “R1-72” and shown outlined in heavy solid lines on Schedule “A” to this by-law.
2. Map Part 3(ar) to By-law 1507 as amended is further amended by deleting the “h1” and “h2” from the Special Zone symbol “h1 h2 R1-72” in respect of the lands shown as “R1-72” and shown outlined in heavy solid lines on Schedule “B” to this by-law.
3. Map Part 3(ar) to By-law 1507 as amended is further amended by deleting the “h1” and “h2” from the Special Zone symbol “h1 h2 R2-1” in respect of the lands shown as “R2-1” and shown in hatched lines on Schedule “B” to this by-law.
4. In anticipation of the eventual consolidation of By-law 1507 and all amendments to such By-law, including this amendment, Schedule “C” and Schedule “D” to this By-law are adopted, such Schedule being Map Part 2 and Map Part 3 to By-law 1507 as amended to include the changes made in such Schedules by all amendments to By-law 1507 to date, including this amendment.

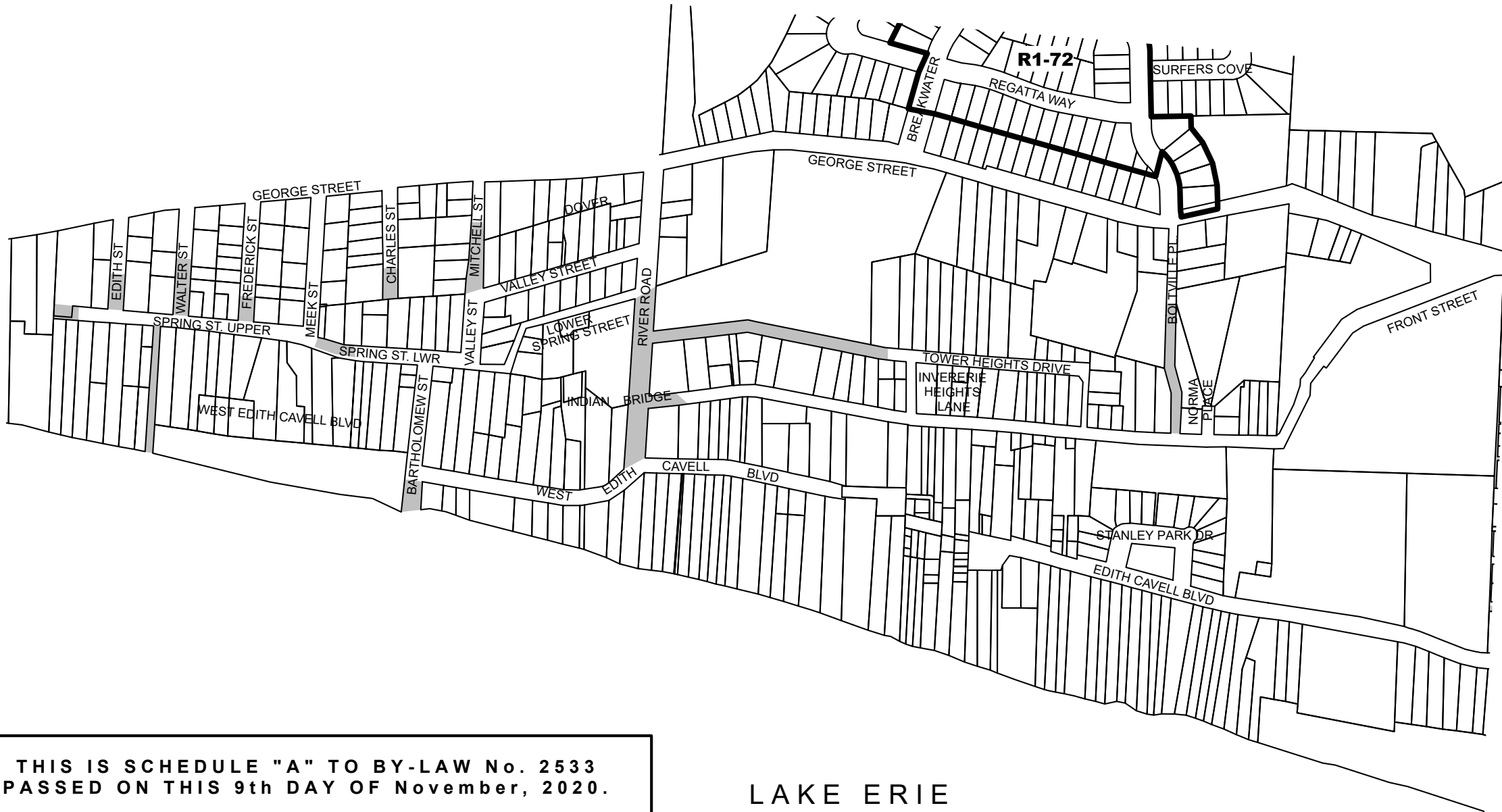

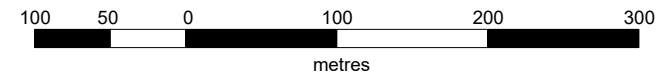

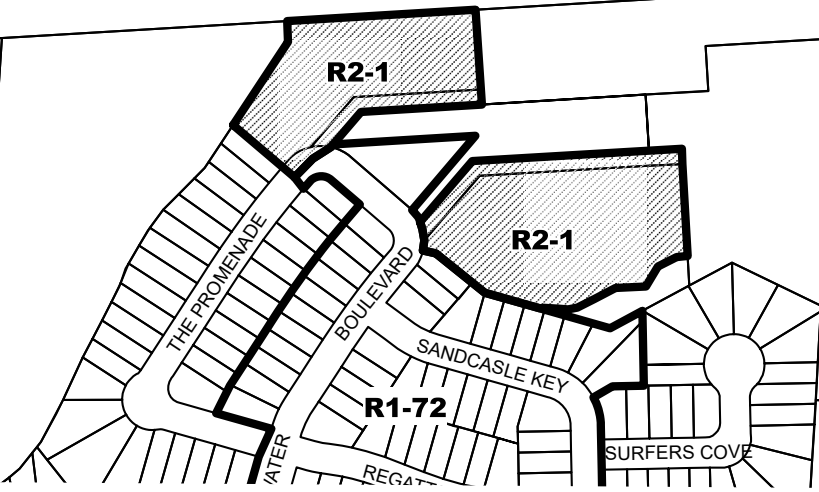

ZONING MAP AND SCHEDULES

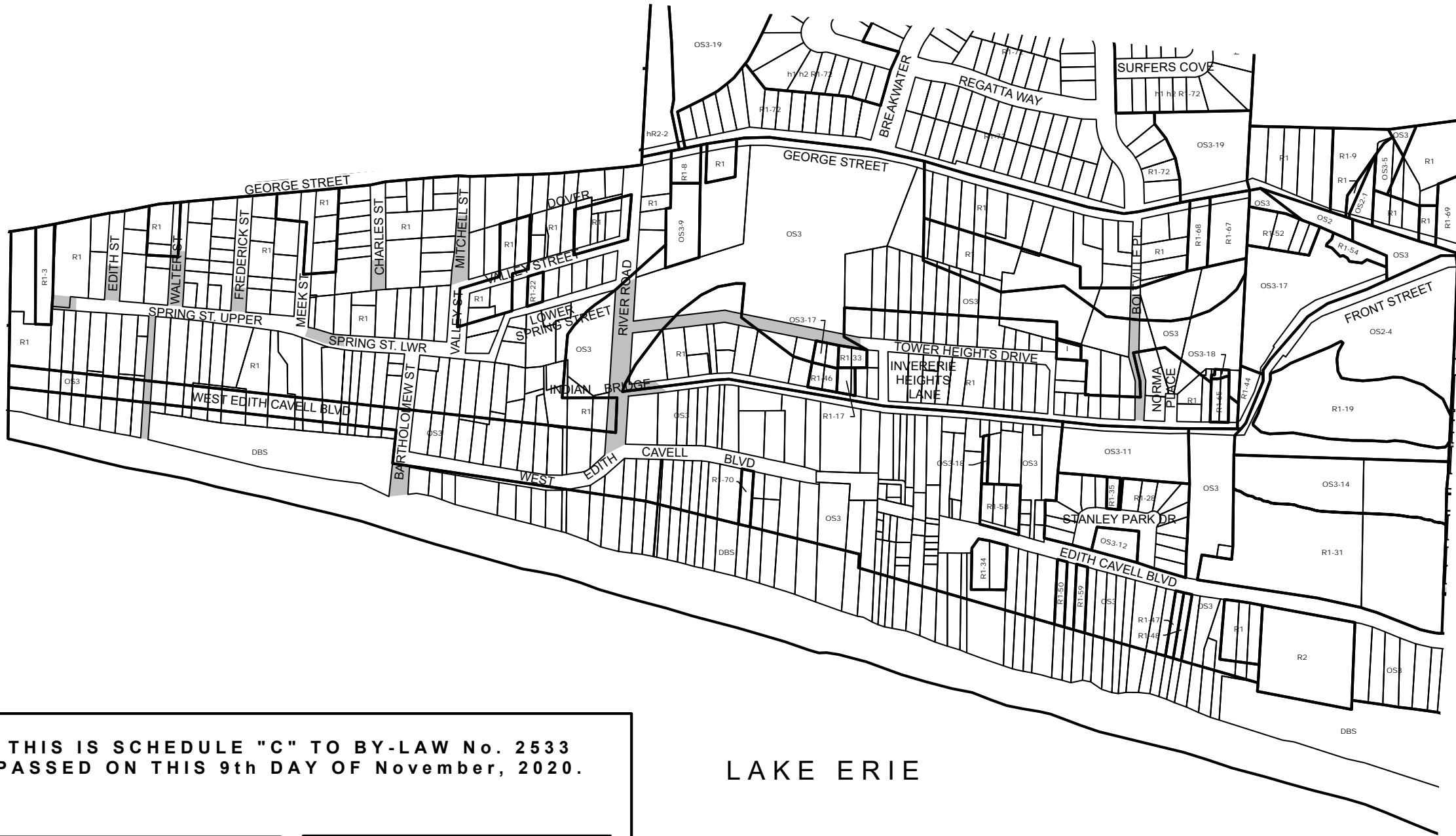

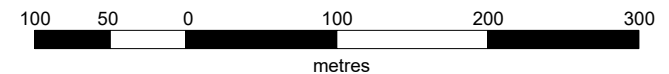


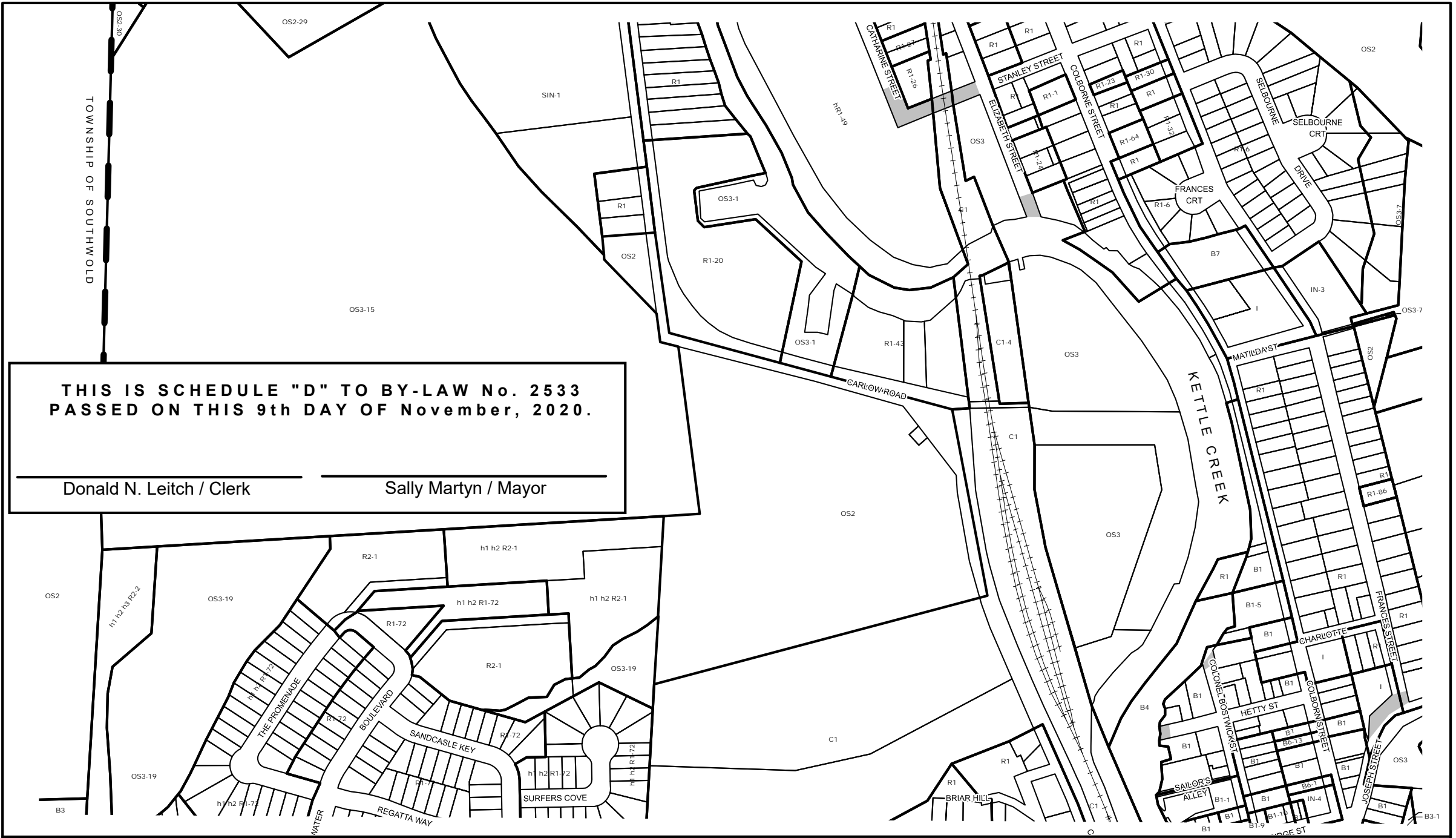
